## STEINER HOMES REFERRING BROKER POLICY

This form must be completed as well as the Steiner Homes registration form to become valid. Completion includes signatures of Realtor and Steiner Homes Representative.

Prior to your client's first visit, you may email a completed registration form to Steiner Homes or you may accompany your client of the first visit and complete the registration form on site. Please note that signatures must be obtained in order for a referral fee to be paid. Registration of clients must occur on or before their first visit to Steiner Homes. Prior registration of the client by a Steiner Homes representative voids the possibility of earning a referral fee.

The referral is active for a period of 90 days. At the end of 90 days, the Realtor will need to re-activate the referral form in order to get paid a referral fee. The re-activation of the homeowner must be signed by a Steiner Homes representative.

In the event that the client purchases a PRE-SOLD single-family home, a total of four thousand dollars (\$4,000.00) referral fee will be paid to the referring broker with a current registration. In the event that the client purchases a PRE-SOLD condominium, a total of two thousand dollars (\$2,000.00) referral fee will be paid to the referring broker with a current registration. Steiner Homes will pay the referral fee in full when the buyer puts the full 10% required down-payment on the home. A down-payment is required at the time of contract signing, along with the customer's pre-approval letter.

If more than one referring broker registers the same homeowner, the referral fee will be paid to the broker with a current registration. Any disputes between seller/buyer/broker will be settled through arbitration.

The Broker Registration Program is subject to change without notice, therefore you are encouraged to obtain the latest policy available at Steiner Homes.
